## Risk Adjustment Variables for CMS Transforming Episode Accountability Model (TEAM)



Risk adjustment is essential to ensure that each hospital's target price reflects the characterics of the patients they serve. But risk adjustment models often explain only a portion of the variation in spending. The factors used to build risk scores for TEAM patients are shown below.
